

# Chile electric vehicle policy



## Overview

---

The Chilean government launched in 2021 its National Electromobility Strategy, which establishes a set of measures to transition to electromobility. The government focuses on regulations and incentives to develop electromobility, considered by a cornerstone to reach carbon. Today, a significant proportion of the population in the capital, Santiago, commutes using electric-powered public transport, thanks largely to a state-led drive towards decarbonisation, aided by private technology and capital that is often sourced from abroad. “Chile is an electromobility leader. Chile has announced a new law changing the existing Supreme Decree N° 145, of 2017 on electric vehicles. This public-private commitment shows a substantial evolution from the previous 2023–2024 agreement, with more institutions involved, broader geographic coverage.


