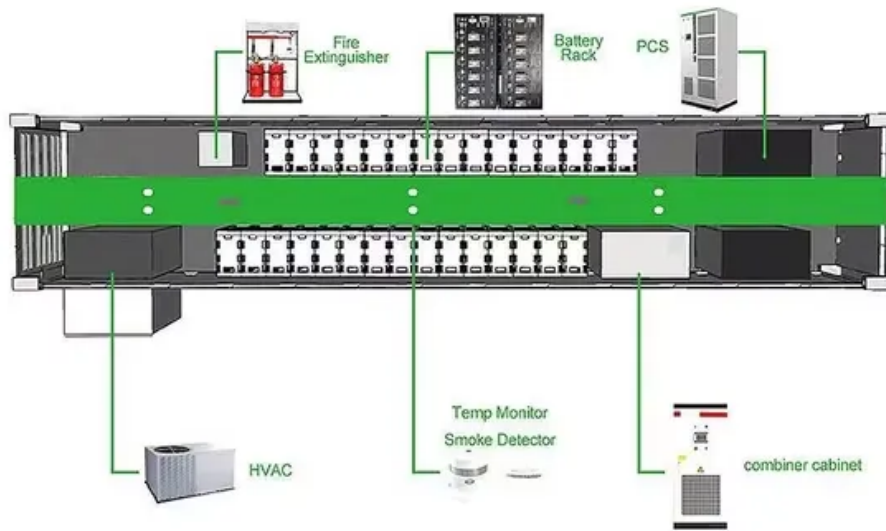


Electric vehicle incentives denmark



Overview

Denmark offers subsidies of ~\$7,000 for new EVs with a purchase price below ~\$46,000. Reduced registration taxes for low- and zero- emission cars are available with rates increasing gradually from 2026-2035. PHEVs receive between 35-50% discount while BEVs receive a 60% discount. Denmark applies a high vehicle registration tax, but BEVs benefit from significant reductions. The taxable value is calculated progressively: From 2021 to 2025, BEVs are subject to only 40% of the calculated registration tax. This rate was planned to be gradually increasing by 8 percentage points. Denmark aims for all new passenger car sales to be electric by 2030 and 100% zero-emission by 2035. A comprehensive agreement between the government, political parties, and stakeholders sets the stage for several key initiatives aimed at making EVs more. A tax investment incentive for the purchase of a zero-emission car amounting to 15% of the purchase price, and a special depreciation applies. Tax incentives: The Danish.
